

Caroline insecurities about her skill could be considered as a social injustice in the form of principle of access, caroline felt she was too late to learn ballet, she felt inferior because she doesn't have an access to learn the ballet dance in early age, she faced inequality in accessing the ballet lesson at early age.

This is similar to what Dorling (2015) said that many societies provide its members with a wide range of goods and services, including education, healthcare, food, shelter, and leisure activities. However, there is frequently unequal access to these services. Therefore, the state of access is in this context of principle is nothing but promote about what is sovereign in the human as being and self (Dorling, 2015). Upper class families can frequently afford to sent their children into a ballet school which is a tertiary needs, but a lower class family might be prioritizing something else in order to survive on a daily basis thus creating an injustice in accessing a ballet school.

c) The Principle of Participation

Participation principle might be denoted whereby each member of society is given the opportunity to express their opinions and concerns as well as a voice in any decision-making that affects their standard of and way of life through participation (Dorling, 2015). The sample explain as follows:



As the COPS dismantle Barnum's makeshift lottery stand, he turns to see Caroline watching him. Barnum smiles bravely.


This scene represent injustice in the principle of participation, Barnum as a New York citizen cannot open a lottery stands to sustain his daily needs, the cops as an institution represented the New York city laws which forbid lottery even though Barnum argues that it is different than gambling they still label it as a gambling.

The scene is similar to what Dorling said about the principle of participation that participation is the process through which each member of society is given the chance to express their thoughts and concerns and a voice in any decision-making that has an impact on their way of life and level of living (Dorling, 2015). This injustice doesn't care on what Barnum said about the matter, in the scene even when Barnum argue that he put some money to build his lottery stand, the cops doesn't care and still dismantle it.

There is also an involvement of public service in this, Barnum's stand and the cops, the cops could be considered as a public service because it was created to enforce the laws in New York, this is similar to what Thirty (1988) said that involving them in decision-making processes about the types of public services required in their communities as well as guaranteeing their full involvement in political and cultural processes are all part of this. The cops was involved because Barnum open a lottery that goes against New York gambling rules, Barnum argues that his lottery stand is a public service because he gave the people of New York a dream when he sold them the lottery ticket, but the cops said otherwise and terminate Barnum involvement in New York cultural processes.

d) The Principle of Rights

Rights or human rights are sovereign and essential to societies that respect the civil, economic, political, cultural, and legal rights of persons, and if they are not upheld, governments, organizations, and people must be held accountable.

Human rights are sovereign and essential to societies that respect the civil, economic, political, cultural, and legal rights of persons, and if they are not upheld, governments, organizations, and people must be held accountable. They hold a significant place in a lot of societies and are acknowledged on a global scale by organizations like the International Criminal Court and the United Nations Human Rights Council(UN Department of Economic and Social Affairs, 2006). In this scene it was Barnum's right to get education was taken by his own father who thinks that it is not important and doesn't give them food on the table, his father as noted above should tried in a court for his violation of his son human rights.
